Hello, my name is Anthony "Tony" Rotella, I am a 15 year Veteran of the U.S. Army (1983-1998). I am currently an active member of S L Brown, Chapter #11 where I am also the current Jr Vice Commander. During my military career I have been assigned to FS Korea / FS Sinop (Turkey) / NCTAMS Naval station (GUAM) / 2 tours at NSA Ft Meade / and Buckley Air Force base.

I have also had temporary duties in Okinawa/ Yokota / Bad Toelz & Winter Harbor. I did my basic training at Fort Jackson, SC (Tank Hill) and my Advanced Individual Training (AIT) at Fort Devens, MA. While stationed in Korea I was the right seater in the OV-1 Mohawk. I also did a 60 deployment on the USS Dubuque (LPD8) in support of the US Navy. I am very interested in becoming an officer in some capacity at the Department level.

Over the last few years I have had first hand experiences on how the DAV helps our Veterans in need. I am truly honored to be a part of this great organization and look forward to helping move the mission of the DAV forward in the future. Thank you all.

#### **BONNIE ROHN : FORT MORGAN CHAPTER #41**

I believe that every veteran can benefit from the DAV. I'm asked often, "what's DAV" (Dave)?" that's a conversation starter! I believe in the DAV, especially the position I hold as Adjutant of Fort Morgan Chapter #41 and Jr. Vice Commander of Department of Colorado. A disability does not have to be seen, it can be what's inside too!

My basic training was in Fort McClelland, Alabama. I went to Fort Sam Houston, TX for Medical training. In the Presidio, San Francisco, I was a flight medic and worked in the Emergency Room. A female medic had to be on board when a female was being picked up. My first and only baby was delivered in the helicopter! While at PSF, I was selected for the Command Military Touring Show in 1972. At Fitzsimmons Army Hospital in Denver I was Coordinator for the Pediatric Clinic and Emergency Room Medic..1973 I went to Germany. I was in Darmstadt with the 557<sup>th</sup> Medical Ambulance Company. I drove a cracker-box! I went to Ludwigsburg, near Stuttgart, where I was with the 32<sup>nd</sup> Combat Support Hospital. In *Primasens Munchweiler Clinic*. I was the only female medic.. After Germany, I went to Colorado Springs.

It wasn't until 13 years ago that I found out about the DAV. I wanted to see how it could help me with my disability and the PTSD that I suffered with. In Chapter 41, the positions I have held are Sergeant at Arms, Officer of the Day, Junior Vice Commander and Treasurer. Presently I am appointed Adjutant. Since joining Chapter #41 in Fort Morgan, there have been many changes, for the better. Some include; Chapter Meetings are held in a local restaurant, so no overhead charge for a building. we had 117 members now we have 140. \$4000.00 raised at the first fundraiser and more. Please support me for Higher Office. I will be here for you, support the Commander and learn more as we take on another year with the Disabled American Veterans!

# VOLUNTEER OPPORTUNITES

#### THROUGH THE DAV

#### "Volunteer hours are tied to dollars and are important when the DAV goes to Congress to let them know all the areas that we continue to assist veterans." ~ Stephen "Butch" Whitehead

The Local Veterans Assistance Program (LVAP) encourages DAV Members and the community to volunteer time to assist veterans in their community with their skills, talents and resources to help with everyday needs. DAV established this program to aid in the mission to *serve disabled veterans* and their families in the community at the local level.

**Examples of LVAP -** that can be reported to Department are as follows:

*Fundraising* – Chapter fundraising efforts (Forget-Me-Not, Golden Corral and other Department approved fundraising)

**DAV Outreach** – Direct assistance to veterans, widows, or families (professional services, yard work, painting, home repairs, grocery shopping, involvement in community projects that support veterans, etc.)

*Veteran Assistance* – Are you a working professional? How about offering free services, to a veteran using those skill sets you have?

#### DSO/CSO - Service Officer Work (training & certification required)

#### **Volunteer Drivers**

Transporting Veterans to and from medical appointments at VA Hospitals is a critical piece of the DAV Volunteer Programs. A volunteer does NOT need to be a DAV member or a Veteran to participate. It is a process to become a Volunteer Driver through the DAV, if you or someone you know is interested, contact Department to get connected to the Transportation Coordinator in your local area.

#### (VAVS) Hospital Volunteers

Volunteering at the VA hospitals and clinics includes socializing with and getting to know patients, supporting patients through their recovery process, aiding nurses, helping at the front desk, instructing and leading group discussions and escorting patients to and from their rooms. Each facility has opportunities available.

#### VOLUNTEER REPORTING


It's very important to <u>report</u> the number of hours for <u>each volunteer</u>. It serves as a barometer to let us know how we're doing as an organization.
