SERVICE OFFICE – REPORT

Service members who incur traumatic injuries, especially in combat; can now receive up to \$100,000 with a one-time payment from the recently created Traumatic Service member's Group Life Insurance. The benefit works like many accidental death policies in the civilian world; but marks the first time that such coverage was available to service members.

The VA vet center program, which provides readjustment counseling and outreach services to combat veterans, is expanding into 23 new communities across the nation. We have a busy one in Jacksonville.

Continuing to honor the nation's commitment to meet the needs of our veterans, a landmark budge of nearly \$87 billion for the VA has been proposed in Washington.

The VA, which already helps train nearly half of the physucuabs in the US, will add 2,000 postions for advanced residency training over the next fire years.

VA Secretary Nicholson has stated that the VA has "on of the most comprehensive and sophisticated electronic systems" for patient records in the nation.

Some 30% of the nearly 700,000 US troops who served in the Gulf war zone have been granted service connection claims and most of them have been processed.

I will be gone on vacation from July 26 to August 26. The office will be closed from Aug 10 to 19^{th} . Because of other possible commitments, the other service officers request that you call the office before, coming in to assure that the office will be manned. We will go back to our regular schedule on August 27^{th} .
