SERVICE OFFICE - REPORT

Some tips on avoiding identification scams: Don't sign the back of your credit card – instead put "PHOTO ID REQUIRED". Do not put the full account number on the "For" line of your checks – just the last four numbers. Use your work phone number instead of your home number on your checks. Never print your Social Security Number on checks. Keep key documents in a safe place. If you wallet is stolen, report it to the police immediately.

A new program for Tricare beneficiaries started in Aug '07, which gives Tricare beneficiaries access to a Member Choice Center, where live customer service reps will assist in making the registration process easier. Their number is 1-877-363-1433. This program also tells physicians that prescriptions can be filled through mail order.

Tricare Prime beneficiaries referred by their primary care manager for specialty services more than 100 miles from the provider's location may be eligible to have their reasonable travel expenses reimbursed by Tricare. Contact your Military Treatment Facility or the Tricare Regional Office for details.

Combat-Related Special Compensation (CRSC) is designed to restore military retirement pay that has been offset by VA compensation when evidence exists to confirm associated disabilities are combat related. Some disabilities that resulted from conditions during peacetime may meet the criteria for CRSC. Eligibility requirement: Be retired with 20 or more years active service; have a compensable VA rating of 10 percent or higher; receive military retired pay that is reduced by VA disability payment. VA says those if you're in doubt about your combat eligibility, submit a claim and let them make the determination.

SBP participants who reach 70 years of age and have made 360 payments (30 years) will no longer have to pay premiums for continued SBP coverage and will be placed in "Paid-up SBP" status.

If you legally change your name because of marriage, divorce, court order or other reasons, tell the Social Security Administration so you can get a corrected card.
