# SERVICE OFFICER

The service office remains busy and even with some service officer illness and the holidays saw 154 veterans during the quarter ending December 2008.

We welcome new service officers Faye Patin and Paul Markiewicz who will accompany us to annual certification training in Orlando 6-9 January. They are both motivated, very sharp, and will strengthen our program. Our service office is staffed with volunteers so remember to tell them they are appreciated.

There are many good things happening in appropriations for veterans. Probably the best news for the majority of us is the increase in the cost of living allowance (COLA) for 2009. At 5.8% it is the largest COLA since 1983 and pertains to retired pay, SBP annuities, social security, VA disability and survivor benefits.

In the area of mortgages, the Veterans Improvement Act of 2008 can now help veterans who have sub prime loans. Both sub prime and conventional mortgages can be refinanced for up to 100% of the value of the property. The maximum amount of the loan has also increased. For more information call the VA.

Your service office remains committed to serving all veterans but especially our own chapter members. If you have a serviceconnected disability that has worsened, consider seeing us for an upgrade. Also many things happen to us down the road which are rooted in our military service. For example, Viet Nam veterans with possible exposure to Agent Orange have a lengthy list of diseases that the VA considers presumptive to exposure. It doesn't hurt to ask us and you might be pleasantly surprised.

We remain committed to you. Call before coming to ensure someone is available, bring all documentation and VA letters, and please contact us when the VA responds about your benefits.
