From Department Jr. Vice Commander Duane Godfrey

Part of the National Defense Authorization Act for 2019 (HR 5515) contains several provisions for veterans, caregivers and certain spouses.

- Sec. 621. Extension of certain morale, welfare, and recreation privileges to certain veterans and their caregivers.
- Sec. 624. Space-available travel on Department of Defense aircraft for veterans with serviceconnected disabilities rated as total.
- Sec. 626. Access to military installations for certain surviving spouses and other next of kin of members of the Armed Forces who die while on active duty or certain reserve duty.
