Simplifies Access to Health Care and Benefits for Veterans with PTSD

www.va.gov or call VA's toll free benefits number at 1-800-827-1000. This regulation in the "Federal Register" should be a substantial improvement in both process and time to process the individual claims. The following is a quote taken from the news article:

"Under the new rule, VA would not require corroboration of a stressor related to fear of hostile military or terrorist activity if a VA doctor confirms that the stressful experience recalled by a Veteran adequately supports a diagnosis of PTSD and the Veteran's symptoms are related to the claimed stressor."

The department receives many phone calls form people having items to donate to the DAV. Often these are veterans or caretakers of veterans. Most of these instances have to be referred to another agency because the department doesn't have the resources to accept and/or place the item. Occasionally these offers do come at a time when the donor and a need can be accomodated.

One such case occurred in June when a donation of a hospital bed was offered. Bob Kent was aware of a need for such a bed. Bob made arrangements for the recipient and donor to connect and the donor was put in contact with veteran of need and arrangements made for the pickup and delivery.

HSC Van Transportation: Hospital Service Coordinator Perez continues to expand the state's van transportation system. From February through June, volunteer hours worked went from 279 to 433; miles driven 2969 to 4737; and most important, veterans transported 98 to 195. Also the number of denials of service have increased as well, March-3, April-4, May-7. It should be noted in June the reason there were no denials is that a loaner van was available from Post Tramatic Rehabilitation Recovery Program (PRRP). The average use of their van was twice a week. This represents the need to increase support for the van program. Individual chapters are strongly encouraged to

support this vital program in the form of fund raisers and any financial support they are able to offer. Marketing the system seems to be gaining momentum, but must be suported by having adequate equipment to meet the needs of the veterans.
