<u>Local Veterans Assistance Program (LVAP)</u>: <u>Comrade D. Jones</u>: As of Oct 2023, our total LVAP hours is 650, in addition to the Golden Corral volunteers fundraiser and Military Appreciation Night last night. Report provided to Adjutant.

Golden Corral Committee: Comrade M. Whitfield: I want to thank everybody for participating. (Chapter applause) Everyone seemed to enjoy it. We raised approx. \$8,000, and 15% goes to the Department. The wheel was great fun, especially for the kids and families. I will be the Department Chair next year for Golden Corral and Camp Corral. National has not provided those dates yet. Anyone interested in being a Chaperone for Camp Corral, please provide your name and I will forward it.

<u>Cdr B. Green</u>: Do you have a list of the winners? Any pictures?

<u>Comrade M. Whitfield</u>: Yes, I do but I don't have them with me. If anyone asks, tickets are burned. Only pictures of winner present were taken.

<u>Cdr B. Green</u>: Have all the prizes been picked up?
<u>Comrade M Whitfield</u>: No, the grill and printer are in the storage locker,

#### Entertainment Committee: Comrade M. Whitfield:

**Loch Raven Annual Holiday Party** (VA Community Living and Rehab Center) I spoke with Mary Jarrod at. I was given 1<sup>st</sup> Sat, Dec, from 12noon to 4pm. I have to complete the application which states we must bring outside food, and all volunteers must complete a training class prior to the event. I will follow up with her to verify more about the training because this is new and let the chapter know. I will find out how many veteran residents we will serve so I can confirm the caterer.

**Chapter Christmas Party**: <u>Cheesecake Factory</u>: No longer takes reservations for over 10 people. I would have to come early on the same day at 5pm to give an estimate of \$35 p/p. There is no set menu. In 2019 we set our cost at \$40 p/p. We may need to increase it to \$45 to stay in the limits with tips separate. If you go over, it is the individual cost. <u>Fridays</u> was the 2<sup>nd</sup> Choice but it was kind of crowded even in the reserved/front part of the restaurant, set price and picked from the menu. Next option was <u>Yard House</u>. Was last year a preselected or individual selected?

Adj D. Rider: The Yard House provided the preselected menu. The Chair/Comrade Redfield and Cdr Ben requested the menu be changed (3x) and include drink, appetizer, entree, and dessert at \$50 p/p with 20% gratuity. Total payment was \$2,790.

<u>Cdr B. Green</u>: I personally liked the Yard House. I would request you to work with the Yard House GM Manager, Wes Patterson. He was very accommodating last year and ask the best time and what you want. He will not charge us the tax.

<u>Comrade M. Whitfield</u>: I will check into the Cheesecake Factory and the Yard house and let the Chapter know.

**Cdr B. Green**: Are we having a gift exchange?

<u>Comrade M. Whitfield</u>: If you want to be part of the gift exchange, bring a wrapped gift and put it on the table. **Forget-Me-Not Campaign**: Adj D. Rider emailed sent to Kelly Paul @ NAF, Fort Meade but no response as of yet. Dates: Sat/Sun 3/2, 3/3, 3/9, 3/10, 3/16, 3/17 and 3/23. (Back up day: 3/24). Adj D. Rider read the purpose of the FMN Campaign. Our Department Chair, Roz Ambose requests that our fundraiser be completed by the 3<sup>rd</sup> DEC, April 6<sup>th</sup>. During the DEC the report is read showing total members worked, total hours worked, total funds collected.

<u>Unfinished Business: Cdr B. Green</u>: Provide an update on our Audit committee. <u>Cdr B. Green</u>: I spoke with the Department and the Chapter will submit our Audit Report by November 30<sup>th</sup>. I have identified 3 members and prepared the folders. Once completed the report will be submitted to the Department and National. <u>Comrade M.
