<u>Adj D. Rider</u> – Cdr and I were told by the Commissary Manager they did not have the space for us to set up.

<u>Comrade R. Henry</u> – Why don't we go with the PX and continue to work approval for the commissary?

Adj D. Rider – On 12/5/2023, Cdr and I visited the AAFES Fort Meade, Service Business Manager, Scott Brintnall and received approval for our FMN campaign at the PX lobby from 10am – 4pm. You manage your time. Again our 1st weekend is Sat, 3/2 and Sun, 3/3. Please email me if you can volunteer. Shifts are 10a – 1pm or 1pm to 4pm.
