<u>Unfinished Business – Cdr G. Ross</u>

- GC Fundraiser/POA Plan of Action approved by State and endorsed by GC Management.
 - Core Hours Fri, Sat and Sun, 2 shifts, must have 2 people per shift, however 3
 members max may sign up/per shift.
 - Weekdays are optional and must follow the core hours and guidelines.
 - Area must be kept professional and clean
 - Check sign-up genius before you report to ensure another member will be present
 - <u>B. Pearman</u> suggested to exchange numbers with Ch13 to help will coverage and contact.
 - Members must wear attire that identifies you as DAV. (davstore.org)
 - August funds collected: Donations of \$3,602.00; Raffles Sales \$457.00; Grand total: \$4,059.00.
- 2. <u>LVAP Hours</u> Hours worked per chapter, , divided by each, multiplied by \$14 p/h the 15% to State. Plan of Action, AAR and LVAP are required by State to release funds to Chapters.
 - Chap13 recorded more hours than Chap33 in August.
 - Ch13 is partnering with Ch33. This is our fundraiser members are highly encouraged to increase our participation, lets step up and show up.
 - <u>E. Smith</u> -Sign up Genius Online. Link available and sent out to members to sign up monthly
- 3. <u>JBK Resolution (edited)</u> JBK Scholarship Program. Money cannot stay with GC, cannot be Nonprofit and turn money into a Profitable company violates the rules and may cause the loss of our tax exempt status.
 - JBK Scholarship. Created by DAV National. Money must be turned into National
 - April through June. National Program. Not Golden Corral
 - Ch33 started a resolution to change the rules to not leave the money with GC due to safety concerns, and severe damage the relationship with GC.
 - Approval process is Chapter State to DEC NEC National Resolution then read one by one to pass or accept it.
 - Per National, Tammy Schafer, you process receipts to account for funds received.

<u>Cdr G. Ross</u> – The resolution should be cancelled because 1) IRS/Maryland rules And regulations, 2) Ch33 is covered under Department Liability insurance and 3) National will not accept receipts. Requested discussion, a motion to present at the Oct 24th DEC. National sends the JBK policy and rules out every year for the last 10 yrs. Chapter 33 has its own EIN Non-Profit tax exempt letter. It's now open for discussion and motion.

- <u>Chaplain M. Ross</u> Discussed forwarding and presenting it at the State DEC, Oct 24th. This will clear up the word of mouth.
- Adj D. Rider The resolution was created for awareness across the State.
 Chapters did not know and were not following the policy.
- B. Pearman Its policy, for guidance and IRS makes it law.

Cdr G. Ross – Is there a motion for the JBK Resolution?

- Chaplain M. Ross I motioned to forward the JBK Resolution to the State DEC
- R. Henry Seconded motion

Cdr G. Ross – It has been moved to forward the JBK Resolution to the State DEC. All in favor say "Aye." Those opposing say "Nay," hearing none. Ayes have it. Result recorded and carried.

- 4. <u>DAV State BBQ</u> Cdr G. Ross Date changed to October 25th, Fort Meade Park, Burba Lake Cottage. Chapter names must be turned into the Adjutant by 10/15. Comrade R. Henry, Chief of Fort Meade Security, is working with our Department Cdr to ensure smooth passage thru the Ft Meade gate for DAV members and guests.
- 5. <u>VA Hospital Collection</u> Cdr G. Ross/SVC L. Miller Donations for 3 VA hospital were sent out. Suggested items were provided. SVC L. Miller will collect your items and turn them in next week. This is how we help veterans. \$200 was voted to offset the items not collected *if necessary*.
- 6. Rumor Control: Cdr G. Ross This is a serious matter. Our DAV principles and motto states IF I CANNOT SPEAK GOOD OF MY COMRADE, I WILL NOT SPEAK ILL OF HIM. There was mention of an incident that the police were called on our Adjutant Deborah Rider during a GC fundraiser. I was told by another chapter while at Golden Corral, that our Adjutant was not allowed to return to volunteer at Golden Corral fundraisers. Adjutant denied the rumor and was felt it was defamation of her character. I advised Adjutant I would investigate. I interviewed past commander, Ben Green, who confirmed it was a rumor that GC didn't want her there using her laptop during the fundraiser. I met with GC managers Labi Hyseni, and Pat Brooks, who stated the incident never happened and didn't even know who she was. Members we cannot put out false rumors or personally attack another member. You can be sued for defamation of character. GC was also glad it was cleared. If you have a concern against another member go to them or use the Grievance committee/CEC. Please present your evidence and remove personal emotions. This incident did not happen and our

- Adjutants name has been cleared. Chapter 33 again always be mindful to our principles comradeship, friendship and loyalty to principle and our comrades.
- 7. By Laws Revision: Cdr G. Ross Our Constitution and By Laws rules state revision have to be discussed during 2 Chapter meetings then vote on changes and add ins at the next meeting. Cdr Ross stated the Chapters Bylaws needed to be updated and changed. He encouraged members to move into a position of leadership, to serve and get involved in DAV business and fulfilling the mission at the local/Chapter level and moving up to State and National. Cdr Ross reminded members that the DAV has only had two women serve as National Commander. CDR Ross highlighted the following Bylaw changes: 2 year Tour of duty for Chapter Officers, LYFT program, No member can sign their own reimbursement checks, Online meetings are permitted per IG but cannot elect officers at online meetings. He encouraged members to review the Chapter Officer Guide and to learn DAV policy and rules. Cdr Ross advised members to review the revisions and prepare to vote at the next meeting.

New Business:

- Corporate Solicitation Committee No December Chapter Meeting. Motioned on 10/11/2022 to have the Chapter Christmas Party at Yard House on 12/13/2022. Chair: Sr Vice Catrina Redfield
- 2. <u>Travel and Reimbursement Policy</u> Mirrors the States policy, emailed to members and will be added to Chapter By-Laws. Noted Travel in the local area / within 50 miles will only be reimbursed for mileage, tolls and parking. Members must be authorized by the Chapter, voted and recorded in the minutes.
- 3. <u>Zeffy Electronic Payments</u>— Free in person payment option. Tap and Pay app. Donations are directly deposited into our bank account through a secure system. Zeffy does not charge nonprofit organizations. EIN Letter will be uploaded to Zeffy to link the accounts. Then the chapter must vote on the actual device to set up at GC for those who do not have cash. Cdr Ross thanked SVC spouse for researching this and soliciting at the mall for donations.
- **4.** <u>Civility / Decorum Cdr G. Ross</u> We are not always going to agree during Chapter discussions. Robert Rules of Order says you have to be recognized by the chair. We must be civil to one another and conduct yourself professionally. We are a non-profit professional organization. We must conduct ourselves and think like a business. Cdr Ross stated, If I've been guilty of any unprofessional conduct, I openly apologize to you and the Chapter and ask others do the same. We don't have to be confrontational.
