Re: Fundraising

All DAV Chapters, DAVA Units and NOTR Dugouts are required to complete a <u>Fund</u> Raising Request Form **before finalizing plans** to hold the fundraiser.

Fund Raising Projects are those where you will be soliciting in any way, shape or form, from the general public. If you are uncertain about whether or not permission is needed, contact DAV headquarters and ask.

Poker, Millionaire Poker Party, Etc.

These types of fund raising projects generally require a written contract or agreement. A Department Fund Raising form should be completed with a copy of the signed contract attached.

All Contracts Need Prior Approval

All Chapters are reminded that a fund raising project involving, directly or indirectly, contracts or agreements of <u>ANY</u> nature shall be required to obtain <u>prior approval</u> from the State Department and from the National Executive Committee. If you are entering into a contract, be sure the contract states that "It is subject to approval of the State Executive Committee and the National Executive Committee."

Contracts submitted for approval, <u>must allow 120 days from the date of submittal</u> until the proposed commencement date of the contract in order for the State and National Executive Committees to give them proper consideration.

The time line for State EC consideration is 45 days and National requires 60 days. The total time line from start to finish is approximately 120 days in advance of the fund raiser.

NOTE: Any chapter or subordinate who conducts a fund raising project without prior approval and/or notice, may subject its charter to suspension or revocation.
