#### Historian

Dec. 7, 1941 - At 7:55 am Hawaii time, Japanese dive bomber bearing the red symbol of the Rising Sun of Japan on its wings appears out of the clouds above the island Oahu. A swarm of 360 Japanese warplanes followed, descending on the U.S. naval base at Pearl Harbor in a ferocious assault. The surprise attack struck a critical blow against the U.S. Pacific fleet and drew the United States irrevocably into World War II.

Dec. 13th, 1636 - The National Guard of the United States, part of the reserve components of the United States Armed Forces, is a reserve military force, composed National Guard military units of each state and the territories of Guam, the Virgin Islands, Puerto Rico, and the District of Columbia.

Dec. 16, 1944 - The Battle of the Bulge was the last major German offensive campaign of World War II. It was launched through the densely forested Ardennes region Wallonia in Belgium, France and Luxembourg on the Western Front in the European theatre. The surprise attack caught the Allied forces completely off guard. American forces bore the brunt of the attack and incurred their highest casualties for any operation during the war.

Dec. 21, 1945 - General George S Patton succumbed to injuries in a military vehicle accident on Dec. 8. He was buried in Luxembourg American Cemetery. Patton requested to be buried alongside wartime casualties of the Third Army.

Dec. 27, 1968 - The U.S. mounts a large-scale air assault against suspected Viet Cong positions in the Mekong Delta using Napalm and hundreds of tons of bombs.

#### Birthdays-

Dec. 5, 1782 - Martin Van Buren served one term as the eighth President of the United States.

Dec. 5, 1839 - George Armstrong Custer - was a United States Army Officer and cavalry commander in the American Civil War and the American Indian Wars. While leading the 7th Cavalry Regiment at the Battle of Little Bighorn, Custer and his entire regiment was killed in what is known today as Custer's Last Stand.

Dec. 28, 1856 - Thomas Woodrow Wilson, better known as Woodrow Wilson, was an American politician and academic who served as the 28th President of the United States from 1913 to 1921.

Dec. 29, 1808 - Andrew Johnson was the 17th President of the United States, serving from 1865 to 1869. Johnson became president as he was vice president at the time of the assassination of Abraham Lincoln. He was the first American president to be impeached; he was acquitted in the Senate by one vote.

These are the vehicles that will be available for sale through a sealed bidding process. If you are interested in one of these vehicles please contact the appropriate DAV Office to place your bid. The bidding process starts December 5, 2016 at start of Business and will continue through January 5, 2017 to close of business. Persons submitting the highest bid for each vehicle will be notified of their win. Full payment is required within 5 business days after being notified of the winning bid. Payment must be made in cash or by cashier's check made payable to DAV Department of Oregon.

For White City and Roseburg vans, payment is to be given to the Corresponding HSC who will, forward payments to Wanda Janus.

For Portland vans: vans and their maintenance records can be viewed at Chapter #1 by contacting Wanda Janus. Payment will be given to directly to her.

Once payment has been accepted by our bank, arrangements can be made to transfer ownership. Winners are responsible for removing all DAV Logos from the van and providing proof of removal within 5 days of taking possession of the vehicle. Failure to remove DAV logos and provide proof of same within the stated time limit will result in \$ 25/ day fee

For Oregon to be considered for addition to the 5k list:

2. 150 Volunteers, who will be trained
3. We are asked to get local donations ( Water, Bagels, etc) we notify DAV National and they will provide letters for sponsors.
4. We notify DAV National of some cities in Oregon where we could hold the event. We also tell them of events (5k, 10k, etc) surrounding Veterans Day, so we do not draw away from them.
5. There is no local funding required; all is done by DAV National
