December 20, 2017

As announced last week, Governor Brown has nominated me to be the next director of the Department of Consumer and Business Services (DCBS) starting Thursday, December 21st and pending Senate confirmation. While I am excited to join the DCBS team and help further their mission as advocates for Oregon consumers, workers and businesses, my departure from the Oregon Department of Veterans' Affairs (ODVA) will be bittersweet.

First and foremost, I will miss the incredible team at ODVA. I have loved telling everyone – from my kids to the Governor and all who would listen – about our team of passionate advocates for Oregon veterans and their families.

I will also miss the daily connection and engagement with the veterans' community across Oregon. We are over 310,000 strong and are a diverse community: men and women, young and old, urban and rural, gay and straight, and every ethnicity, and creed. Our diversity does not divide us, and with the leadership of the national service organizations and community partners we advocate with a united veteran voice.

Together as a veterans' community and with the broad and bipartisan support of our elected leaders, we have made a tangible and meaningful difference in the lives of our veterans, all Oregonians and the state as a whole.

With a focus on our mission, our state has invigorated core programs and partnered on broad community efforts to assure our veterans' health, education and economic opportunity. We should all be proud how we have strengthened services for all veterans and focused outreach to underserved veterans including aging, women, LGBTQ, tribal, and rural veterans.

Given our timeless and essential mission to serve and honor Oregon veterans, I am also very pleased that Governor Brown has nominated Sheronne Blasi to be the next director of ODVA pending Senate confirmation.

I first met Sheronne when she and her team of performance audit managers at Secretary of State completed a thorough review of veteran services in 2013-14. We recruited her to our team this year and she has been serving as assistant director of Statewide Veteran Services. Sheronne is a long time Salem resident and active community member, and served 14 years in the United States Navy.

Sheronne has my and our Advisory Committee's full confidence and support. She has proven herself to be a strong leader who will be able to help our team continue to strengthen our core programs and build broad community partnerships to achieve on

our mission. Her first day as director will be Thursday, Dec. 21st. Please join me in congratulating and welcoming Sheronne to her new role as director.

Thank you again for the honor and privilege of being a part of team ODVA and our shared efforts to better serve Oregon's veterans and their families. I look forward to staying in touch and continuing to be a part of Oregon's veteran community!
