
Continue following & addressing our legal system with veterans issues.

Well, it is time for us to all start making plans to attend State Convention June 12, 13 and 14 in



When you get this we will be back from Mid-Winter. I believe we all learned and I know we are heading in the right direction if we don't let our Legislators ignore what the American people continue to say "Treat our veterans right, do what is in the best interest of our veterans" or as we say in Texas "Don't mess with our VETS"

I have been honored to serve as your Legislative Director this year and was honored to be elected to serve on the National Legislative Committee during the National Convention in Las Vegas. In the fall I received a letter from our National Commander stating that he had appointed me to serve on the Interim Legislative Committee for National.

I was called into the Mid-Winter Conference for a Legislative Meeting and to accompany the National Commander to attend the House and Senate Committees on Veterans Affairs as he gave his testimony for the Disabled American Veterans.

His testimony was an in depth statement of the VA and the VAHC systems and how they must be funded properly, how converting to private care is not the answer and would be more expensive, and would not adequately give Veterans the care they were promised, and deserve. It covered our four major talking points:

Women Veterans, Comprehensive Caregiver Support, Fiscal Year 2016 VA Budget, and, Fully Developed Appeals.

- 1. Women Veterans; Reintegration challenges for women; Gaps in services for women; existing services not sensitive to the needs of women or equal to care for men.
- 2. Comprehensive Caregiver Support;
 There is a cost to providing access to VA's
 Caregiver Support Program. However it costs
 less to provide than it does to provide nursing
 home or other institutional care. A VA report to
 Congress shows the average cost per veteran is
 cheaper than private, state, or other federally
 funded care. It allows veterans to remain at
 home with their loved ones.
- 3. Fiscal Year 2016 Budget; VA programs have been underfunded for years, There should not be any shock that under funding of the VA has led to unmet demands. With the drawdown of forces of approximately one million members separating in the next few years demand of services are going to grow. The budget must be sufficient to enable the VA to keep up with the pace. There will be needs for more staff, more facilities, more equipment and upgrades.
- 4. For the past four years the VA has focused on a 2015 target goal of zero claims pending more than 125 days at 98 percent accuracy. As of January 22, 2015 over 350,000 appeals were pending. The average time for processing an appeal can now require from two to five years. The VA with the DAV and other Veterans Service organizations are trying to develop a proposed FDA pilot program.

The Talking points listed with "The Situation", "The Challenge", and "The Solution" for all four Talking points can be downloaded from the DAV.org website.

There are several State Bills we are supporting and these will be available on the Department's website shortly.

REMEMBER: You can make a difference in a veteran's life.

No American, especially one serving in our Armed Forces, should be forced to abandon his or her religious beliefs. Yet the rigors of military life – from boot camp to battlefield – bar our military from many things that civilians take for granted, such as attending church, participating in a Bible study, or even having a good discussion about their faith. So when General George Washington long ago commanded his officers to "procure chaplains..." he foreshadowed what our Constitution now mandates: that the military provide chaplains to enable service members to freely exercise their religious faith. And this is exactly what chaplains have nobly done since pre-Revolutionary times serving their fellow believers and serving all military men and women by *nurturing the* living, caring for the wounded, and honoring the dead. Last month at out mid-winter department meeting many asked about a DAV chapter's chaplain's duty. First and foremost please take a look at the 'Official Ritual of the Disabled American Veterans' and follow those guidelines. Here is just a brief note on what a DAV Chaplain' should consider. The DAV Chaplain serves a vital role in the lives of men and women in the DAV. Faith comes from hearing the Word of God. Veterans, like men and women everywhere, need to hear the Word of God proclaimed with vigor, conviction and love. Many veterans are often looking for religious guidance, or simply a friendly, approachable face

and an encouraging word. Some look to the Chaplain for comfort during times of emotional stress, when facing moral conflict, or the sadness of grief. The DAV Chaplaincy is a challenging and dynamic opportunity to reach out to men and women from various backgrounds of culture and religion in order to present the eternal Truths of God. Because the Chaplain knows firsthand what the veteran is going through, you are able to develop a special bond of spiritual friendship that makes it easier for the veteran to openly share their concerns and heartaches. Being a Chaplain for the DAV will utilize all your talents and stretch your abilities to their widest potential. DAV Chaplains have been bringing God's message of faith and life to veterans and their family members for over 90 years. The DAV chaplain shall act as the official spiritual representative of the Chapter. It is important to remember that our organization is composed of all faiths and religions. The role of the chaplain in the DAV is a very special one, and the duties of the chaplain are significant. A chaplain must always be aware when offering prayers and guidance not to offend any religion but to respect and honor all. Serving as chaplain provides the opportunity to guide members in fulfilling the purpose of our organization. The chaplain may be called upon in many ways - in visitations to hospitalized members, and with the approval of the Chapter may appoint one or more members to assist in these duties. The chaplain should also officiate at funerals or memorial services. The chaplain will also be called upon to render assistance at chapter meetings and to chapter members and their families. As the spiritual leader of the chapter, it is important to follow the ritual for all regular meetings and to use the Blessing and Closing Prayer as printed (in the rituals book) for regular meetings or one that is applicable. By doing so, the chapter meetings will begin and end in an inspiring manner. Not all chaplains are ordained ministers and some of the duties might be

limited. As an Ordained Minister, when I served as chapter chaplain, I performed not only memorial services and officiated at funerals, but also offered my services (free, do not ever charge a fee) to chapter members to perform several marriage ceremonies, baby dedications and more. Speaking at military reunions, visiting veterans in nursing homes and reaching out to local churches for new members can also be a great way for chaplains to serve their chapters. Offering CSO services to veterans in local churches can be a great recruitment tool. There are many other duties a chaplain can assist with, but most importantly a chaplain is a servant. A chaplain must have a servant's heart. A chaplain must be the greatest servant among his members. In closing I would like to offer my telephone number to any chaplain that needs advice or assistance. I'm a sinner, like most, not perfect and don't have all the answers, but together we can get them. There are many resources within the DAV including our National Chaplain and elsewhere.
